

# CONTACT YOUR LEGISLATORS

The only way to stop the cuts is to restore transit funding! Most legislators have heard about the transit cuts but aren't familiar with how bad they are, and the importance of operating—not capital—dollars to bring back service. Let them—and the candidates in the upcoming elections—know how the cuts will affect you and ask them to restore funding. **This is the most important thing you can do!**

## SPEAKING POINTS

- **Bus riders are taking a disproportional hit; bus service is being reduced by almost 40%!**
- **Bus service is lifeline transportation for people with no alternatives — riders will lose their jobs and their health care.**
- **We HAVE bus capital funding, but we need bus OPERATIONS funding.**
- **Ask them to restore operations funding or make existing capital funding flexible on a temporary emergency basis.**
